In addition to the regular homestead exemption authorized for all homeowners, certain elderly persons are entitled to additional local and state exemptions. The full law relating to each exemption must be referred to in order to determine eligibility for the exemption. If you are eligible for one of these exemptions and are not currently receiving the benefit of the exemption, you must apply for the exemption no later than April 1.
